# Dog Onsite Policy at Horizons Education

### Purpose:

Horizons Education recognizes the positive impact that dogs can have on students' emotional well-being, social development, and overall learning experience. This policy outlines the guidelines and procedures for allowing dogs to be onsite at Horizons Education.

### Scope:

This policy applies to all students, staff, and visitors at Horizons Education who wish to bring their dogs onto the school premises.

### Policy:

- 1. Permission and Approval:
  - Prior approval must be obtained from the school administration before bringing a dog onsite.
  - A written request must be submitted to the administration outlining the purpose and duration of the dog's visit, as well as any special accommodations required.
- 2. Health and Vaccination Requirements:
  - Dogs must be in good health and free from contagious diseases.
  - Proof of up-to-date vaccinations, including rabies, distemper, and parvovirus, must be provided prior to the dog's visit.
- 3. Behavior and Training:
  - Dogs must be well-behaved and trained to follow basic commands, including sit, stay, and come.
  - Aggressive or overly disruptive behavior will not be tolerated, and the owner may be asked to remove the dog from the premises.
- 4. Supervision:
